NOTICE OF INTENTION TO CIRCULATE RECALL PETITION

Administration

TO THE HONORABLE JAMIE L. IRONS: Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of the City of Morro Bay, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of Mayor, in the City of Morro Bay, California, and to demand election of a successor in that office.

THE GROUNDS FOR THE RECALL ARE AS FOLLOWS:

Jamie Irons is having a detrimental effect on the City of Morro Bay. In his first year in office, he has:

- 1) Disregarded his campaign promise by withdrawing the wastewater treatment plant from Coastal Commission review, negating 8 years of work, and proposing a new project that will burden ratepayers with over \$40 million in additional
- 2) Acted precipitously to dismiss the City Manager and City Attorney, admittedly without cause or a succession plan, and without regard to the negative effect on the city's operation, finances and morale.
- 3) Demonstrated lack of respect for the law by attempting to take actions without the knowledge and approval of entire Council:
- 4) Attempted to influence staff and edit staff reports previous to their presentation to Council;
- 5) Reversed campaign assurances by raising building fees and supporting tax increases, indicating lack of concern for our citizens' economic welfare;

Jamie Irons consistently puts his own agenda and interests ahead of his constituents and fellow Council Members. His disregard for the welfare of Morro Bay and its citizens must not continue. He should be recalled.

Elections Code 11023. (a) Within seven days after the filing of the notice of intention, the officer sought to be recalled may file with the elections official, or in the case of a state officer, the Secretary of State, an answer, in not more than 200 words, to the statement of the proponents. (b) If an answer is filed, the officer shall, within seven days after the filing of the notice of intention, also serve a copy of it, by personal delivery or by certified mail, on one of the proponents named in the notice of intention. (c) The answer shall be signed and shall be accompanied by the printed name and business or residence address of the officer sought to be recalled.
